Subject: President/CEO Message - May 17, 2024 (revised)

Campus Community,

Happy Friday! And the marathon continues to the Compton College Commencement Ceremony. As we push toward *June 7, 2024*, please remind your graduating students to consider attending at least one of the many graduation celebrations planned this month. For some students, this may be their first time participating in an in-person commencement ceremony, and I am extremely excited we have the opportunity to share this moment with them.

Thank you to everyone who participated in Classified Professional Development Week and Classified Professionals Day, and most importantly, thank you to the members of the planning committee who coordinated today's event. As I mentioned in my remarks this morning, I still remember when the partnership began with El Camino College. During the partnership, all the Classified Professional Development Week events and Classified Professional Day were held on their campus, and our employees had to travel to participate. It was recommended then that we host our own Classified Professional Development activities on our campus, and it may have taken a while. Still, we eventually made the transition to separate events. We have come a long way as it relates to our Professional Development Program at Compton College. I truly appreciate everyone's commitment to lifelong learning and professional growth.

As mentioned in the <a href="President/CEO Message">President/CEO Message</a> – May 10, 2024, Governor Gavin Newsom released the May Revision Proposal for the 2024-2025 fiscal year. Earlier this week, the California Community Colleges Chancellor's Office (CCCCO) released the <a href="2024-2025 Joint Analysis of the Governor's May Revise Budget Proposal">2024-2025 Joint Analysis of the Governor's May Revise Budget Proposal</a>. This detailed and comprehensive tool is crafted to serve as a common factual resource to aid further analysis or advocacy. The CCCCO once again partnered with the Association of California Community College Administrators (ACCCA), the Association of Chief Business Officials (ACBO), and the Community College League of California to release this analysis. In the coming week, I will be working on a letter to our statewide elected officials regarding the May Revise and our support of the Governor's May Revise Budget Proposal.

# **Summer and Fall 2024 Enrollment Update**

As of yesterday, May 16, 2024, Compton College has generated:

- 373 FTES for the **Summer 2024** term. The fill rate is currently 54%, and seats filled is 3,010.
- 376 FTES for the Fall 2024 semester. The fill rate is currently 13%, and seats filled are 2,132.

The Searchable Schedule of Classes is available online for summer and fall 2024.

Fall 2024 registration opened on *April 30, 2024*. Current students are advised to <u>meet with their counselor</u> as soon as possible to discuss course options and continued progression toward their educational and career goals.

As always, I am very concerned about enrollment, which is normal for me. Although I am encouraged about the summer 2024 enrollment numbers, we still need to remind our current students to register now before classes fill.

### **Compton College Athletics Update**

- Women's Softball Fifteen student-athletes completed the Spring 2024 Season with a fantastic ending
  in the playoffs for the first time in Compton College's Athletic history. Overall record of 21-18 (SCC
  Conference 9-12. 5<sup>th</sup> Place). Head Coach Victoria Castillo had a committed and competitive group of
  student-athletes this year, with three students recognized as all-conference honors: Serena Velez,
  Venezia Uribe, Destiny Vega, and Danielle Varela.
- Men's Baseball Completed their traditional season Overall record 16-24 (Conference 10-14, 5th Place). Eight-two student-athletes are in the program, with 50 on the roster for the 2024 season. Coach Shannon Williams led the squad with seven coaches supporting the student-athletes. We had a committed and competitive group of student-athletes this year with experience playing competitive high school and travel baseball. Two students were awarded all-conference: Catcher Emilio Morales and Designated Hitter Jalen Ringwood. Coach Williams will be recognized by the Los Angeles Dodgers for Teacher of the Year on *Sunday, May 19, 2024*, at Dodger Stadium during <u>Teacher Appreciation Day.</u>
- Men's Football Forty-two student-athletes are currently enrolled in the Summer 2024 pre-season football class. Recruiting is going well, and the plan is to have 65+ students in the program for Fall 2024. They are learning football skills, committing to being student-athletes and acquiring life-long skills in spring football and weight training classes.

# **Closing the Loop**

The inaugural Dean's List Celebration was held last *Thursday, May 9, 2024*. The Dean's List recognizes students for academic excellence upon completion of twelve or more units with a grade-point average of 3.0 or higher in one semester. A total of 457 students made the Dean's List for Spring 2023 and Fall 2023. Fifty-two students made the Dean's List for both terms. There was a great turnout, with approximately 80 students attending the celebration and receiving certificates and pins. They were each given the opportunity to be publicly recognized and take a picture with our academic deans. Approximately 50 Compton College employees and community members attended the ice cream social and acknowledged the accomplishments of these students.
