## Enrollment Update as of May 8, 2025

- 335 FTES for the **Summer 2025** term. 2,689 (49%) of the available Summer seats are currently filled.
- 265 FTES for the **Fall 2025** term. Our fill rate for Fall is 10% with 1,605 seats filled.

Summer 2025 registration is currently 17% ahead on FTES and 24% ahead on headcount compared to last year's equivalent day. Thirty-two of the 175 available summer sections are full and have started waitlists.

Fall 2025 open registration started on Tuesday. Enrollment counts at this early point in the term are equivalent to last year's performance.

### **Important Reminder: Understanding Your Rights in Campus Spaces**

As part of our ongoing efforts to ensure a safe and informed campus environment, we would like to remind you of the distinctions between different campus spaces and your rights regarding access and privacy.

Classroom vs Office Space

- **Classroom**: Reserved for educational activities, accessible to enrolled students, faculty, and authorized staff.
- **Office Space**: Used for administrative purposes, accessible only to authorized personnel such as faculty, staff, and specific visitors.

Authorized Personnel vs Public Space

- **Authorized Personnel**: Includes faculty, staff, and registered students who have specific permissions to access certain areas.
- **Public Space**: Open to the general public, including lobbies, hallways, restrooms, dining areas, and outdoor spaces.

## Access by ICE Agents

- **Public Spaces**: ICE agents can enter public areas without special permission.
- **Private Spaces**: ICE agents require a valid judicial search or arrest warrant to access private or non-public areas, including classrooms and office spaces.

**Reminder to follow** Administrative Regulation 3415 – Immigration Enforcement Activities: Faculty and staff should notify the Office of the President/CEO or Campus Police immediately if an ICE agent is on campus. Any warrants, court orders, or subpoenas should be verified by the designated administrator or legal counsel before compliance. In cases of exigent circumstances, immediate compliance may be required, but Campus Police should be contacted as soon as possible. If you observe any suspicious activity or have concerns, please report them immediately to the Compton College Police Department, located at the Artesia entrance to campus, or call 310-900-1600, ext. 2790.

**Know Your Rights Red Cards:** 'Know Your Rights' Red Cards are available for pickup at the Community Relations Office, located in the Administration Building, Room 112. These cards provide important information on immigration rights and are available in both English and Spanish.

Please ensure you are familiar with these distinctions and your rights within these spaces. If you have any questions or need further clarification, do not hesitate to contact Campus Police. Similar information was emailed to all Compton College students this morning.
