Subject: President/CEO Message - May 16 2025

Campus Community,

Wow, we are inching closer and closer to the end of the spring 2025 semester, and I know we are all counting down the days to the 2025 Commencement Ceremony. As the countdown continues, I am hoping we all take some time to reflect on the amazing work we are doing in support of student success. I was looking at the tentative numbers of degree and certificate recipients, including our dual-enrollment students from our local high schools. It is amazing to see so many students from this community completing their educational goals at Compton College.

In 2021 and 2022, Compton College implemented a **Zoom-Free Day**—a designated workday without meetings—to provide employees with uninterrupted time to focus on individual tasks and responsibilities. This initiative was well-received and aligned with a recommendation from the Academic Senate.

We are now considering reintroducing a **Zoom-Free Day** before the end of the fiscal year. On this day, employees would report to work as usual and classes would continue as scheduled; however, no meetings would be held. The goal is to provide a brief reprieve from the demands of virtual meetings and allow time for reflection, planning, and productivity.

The <u>Consultative Council</u> will be asked to select a date, and we will notify the campus community once it is finalized.

Today's President/CEO Message includes summer and fall enrollment information, one last reminder about Tuesday's Campuswide Forum, the 2025-2026 ASG election results, a joint analysis of Governor Newsom's May Revise Budget Proposal, and more.

Enrollment Update as of May 15, 2025

- 387 FTES for the **Summer 2025** term. 3,131 (56%) of the available summer seats are currently filled.
- 390 FTES for the **Fall 2025** semester. Our fill rate for Fall is 14% with 2,412 seats filled.

Summer 2025 registration is off to a strong start, currently tracking 11% ahead in FTES and 14% ahead in headcount compared to the same time last year. Over half of the available seats are already filled, with 42 out of 176 sections at full capacity and waitlists underway.

Fall 2025 registration is also showing growth, with FTES up 4% and headcount up 14% year-over-year. Already, 14% of the 16,757 available seats have been claimed, and 5 of the 559 sections are full and waitlisted.

We encourage you to remind students to:

- Please register early to secure their preferred courses
- Meet with an academic advisor to align their course selections with their educational and career goals

2025-2026 Governor's May Revision Budget Proposal

This week, California Governor Gavin Newsom released the May Revision proposal for the 2025-2026 fiscal year. The revised budget addresses a projected \$12 billion deficit through program reductions, fund shifts, and borrowing.

For community colleges, the proposal maintains core funding and supports workforce development, with overall funding levels remaining steady. Key highlights include:

- 2.3% COLA for apportionments and additional funding for categorical programs
- \$139.9 million to support 2.35% enrollment growth
- Reductions to previously proposed one-time investments in technology and workforce initiatives
- \$68.5 million in capital outlay funding for 30 projects, including life-safety improvements

In the coming week, I will be working on a letter to our statewide elected officials regarding the May Revise and our support of the Governor's May Revise Budget Proposal.

Finally, we will review the Governor's May Revision Proposal and make any necessary updates to the 2025-2026 Compton Community College District Tentative Budget before submitting it to the Board of Trustees at their *June 16, 2025*, meeting.
