Financial Aid awards posted under **YOUR** MyECC account are estimated awards. Financial Aid payments are based on the number of units you're enrolled in each semester. **YOU** must maintain Satisfactory Academic Progress (SAP) which requires an overall 2.0 G.P.A, and a pass rate of 67% each semester. **YOUR** Financial Aid award will be disbursed in (3) payments, each semester.

All disbursement dates are estimated; the Financial Aid Office cannot guarantee the date you will receive your funds. We recommend you have an alternate plan if there is a delay in your funding.

Students who met the priority deadline of June 30, 2018 will be paid on the 1st scheduled disbursement of the semester. Students who do not meet the June 30th priority deadline will be paid approximately 3-4 weeks after they receive notification that their financial aid file has been awarded.

The Freeze Date for Fall 2018 is September 10, 2018 and for Spring 2019 semester the Freeze Date is February 25, 2019. Students must be registered for all courses by the FREEZE DATE in order for all units to count for financial aid.

Students, who are waitlisted for a course and have already received their Pell payment based on their original enrollment, may receive the difference, for course(s) officially added by the FREEZE DATE, at a later payment date.

Pell Grant is generally disbursed in three payments per semester.

Students awarded Cal Grants and other aid will have paper checks mailed to their address on file. Please keep your address up to date with the school!

Winter Disbursements: Winter units are added to Spring units for Pell Grant purposes and will be paid during Spring disbursements. Payment of Pell and Cal Grant is prorated based on a student's enrollment status per term.
