#### **1) Review of September 16, 2020 Meeting Minutes**

The Committee reviewed the minutes from September 16, 2020 meeting.

#### **2) Compton College Resocialization Plan – Andree Pacheco, Director, Student Development & Athletics**

Director Pacheco gave a presentation on the Compton College Resocialization Plan that was presented at the Board of Trustee Meeting on Tuesday, October 20, 2020. This information is being provided to all Student-Athletes, Coaches, and Athletics Staff so that when the process of Resocialization begins everyone is familiar with the process and it will help with a smooth transition.

This plan covers the following topics: Re-Socialization Period, Student-Athlete Onboarding, Positive COVID-19 Test, Intercollegiate Courses, Social Distancing, Sport Activity Descriptions, Return to Regular Practice & Competition, Athletic Facilities, Other Athletic Operations, Forms, Handouts and Matrix. This document is fluid and is available on the Board Agenda dated 10/20/2020.

#### **3) Eventual Return to Campus Plan – Heather Parnock, Director, Community Relations**

Director Parnock provided an update for the Eventual Return to Campus Plan which is a living document and is constantly being updated.

Topics covered were:

- Update Wellness Check Questionnaire protocol
- New online Individual, One Time Request Form

- Updated COVID-19 testing protocol for essential employees and CTE faculty/staff (required monthly), CTE students are required to submit test results prior to arrival on campus
- Updated Center for Disease Control, California Department of Public Health and Los Angeles County Department of Public Health guidelines for institutions of higher education (*guidelines are changing weekly*)
- Update ‘Exposure Management/Communication Protocol’ to include LACDPH reporting requirements
- Add available COVID-19 leave options
- Phase 2 focuses on Fall 2020
- New appendix item(s)
  - MLB
  - Nursing 244
- Phase 3 will most likely focus on Winter 2021

**5) Discussion Items/Reports**

- a) Reports from Compton College Pandemic Coordinators  
This report was covered under the update provided by Director Parnock in the Eventual Return to Campus Plan.

- b) Report from Compton Fire Department  
Captain Ivan Verastegui reported that the Fire Department has moved a Paramedic Squad to Fire Station 44 which is located at Walnut St. & S. Wilmington Ave and which is the primary fire station that covers Compton College. By moving this Paramedic Squad to Station 44 this will improve response times to the College.

The Fire Department is seeing the same amount of COVID cases this month as they did the previous month. We are also seeing an increase in mental health calls, domestic violence calls, and cardiac arrest cases. We are also seeing an increase of PPE supplies being used because most of our calls are now requiring full PPE. Fire Department members were given the option to receive either the influenza vaccine and if they chose not to receive it they would be required to wear a mask at all times. Any visitors to City Hall must have their temperatures checked and be screened for any possible symptoms of COVID-19 prior to entry.

After speaking with a few CPR Instructors, he has confirmed that CPR classes are available but many of the Instructors are only teaching small groups.

- c) Report from Compton Unified School District  
Chief Box advised the Committee that Chief Wu is out of the office this week, and that Capt. McFadden said there is no updates for this month. Chief Box also advised that if an update becomes available he will email it out to the committee.

**6) Pending Items**

- a) CPR First Aid Proposal – Professional Development  
Chief Box proposed to the Committee that CPR training should be provided to the Building Captains and other First Responders as Professional Development training. He mentioned that

it would cost approximately \$6,000 to training 40 people. He also mentioned that while a lot of the training can take place online, but the practical skills portion would need to be completed in-person because of the use of the CPR mannequins.

b) Questions / Comments

Chief Box - Construction is happening on campus, some staff are commenting that there is a lot of dust in the area and causing cars to get dirty, Chief Box will be recommending to construction that they wet the dirt to cut down on the dust created by the working being done at the construction site.

Eyob Wallano – COVID 19 Vaccines will be given to essential medical personnel. COVID-19 will increase as the temperatures increase.

Abdirashid Yahye – Can St. John’s send the student/faculty test results to HR with student/faculty permission to reduce paperwork?

Heather Parnock – St John’s can send the information electronically to the student/faculty with written consent, but they are not allowed to forward them on to HR

Abdirashid Yahye – Will provide questions and concerns from Faculty and students regarding CTE to Chief Box for the meeting being held on 11/3/2020

Chief Box – Professors please let the students know that they must have some form of identification in order to receive services on campus, we are not running anyone’s information when we request identification it is specific for COVID -19 verification / screening purposes.

Benson Atkins – I would like to congratulate the Police Department and its leadership for all of its hard work during the COVID Crisis, you have all done a fantastic job and are really keeping things in line.

Leonard Clark – Is it necessary to sanitize student athletes uniforms?

Andree Pacheco – It is necessary to wash and sanitize all uniforms once they are used to help stop the spread of COVID-19. All uniforms are collected after each event and are washed either that same day or by the next morning.

Eyob Wallano – It is important to note that the shoes that the athletes are using during practice and games should be their own shoes and the school should not be providing them with shoes because of the spread of COVID. Also, the shoes that the athletes are using for their sporting activities should be kept far away from their normal everyday shoes, so that they are not taking the virus with them wherever these shoes are worn including in the car. The Athletics Department should work to come up with a plan to deal with Athletes and they should look at where these shoes are coming from prior to their entry to campus.
