Recognizing Compton College as the 114th California

Community College under the authority of the Compton

Community College District Board of Trustees

Executive Order 2018-01 is issued pursuant to Resolution 2017-02 of the California Community Colleges Board of Governors, and declares that Compton College will operate as the 114th California Community College under the authority of the Compton Community College District Board of Trustees effective June 7, 2019 at 11:59 p.m.

WHEREAS, the Compton District and the El Camino Community College District, along with state, local, and community partners, have worked diligently for several years to achieve accreditation for Compton College; and

WHEREAS, on June 7, 2017, the Accrediting Commission for Community and Junior Colleges (ACCJC) granted initial accreditation status to Compton College; and

WHEREAS, since the Board of Governors formally recognized Compton College as the 114th California Community College, the Compton District and El Camino District formed the El Camino College/Compton College Transition Committee to work together and implement a partnership transition plan to restore local control of Compton College to the Compton District.

WHEREAS, on June 20, 2018, as required to change local control of Compton College from the El Camino District to Compton District, Compton College submitted the Substantive Change Application - Change in Local Control to the ACCJC Substantive Change Committee.



WHEREAS, on August 24, 2018, the ACCJC Substantive Change Committee reviewed and approved the Compton College Substantive Change Application: Change in Local Control.

WHEREAS, the Compton District and the El Camino District will consider resolutions terminating their partnership effective June 7, 2019, at 11:59 p.m. Once approved, the Compton District Chief Executive Officer and the El Camino District Superintendent/President will provide notice to the Chancellor's Office that the partnership will be terminated effective June 7, 2019, at 11:59 p.m.

WHEREAS, as a predicate to the dissolution of the partnership, the Compton District requests that the Chancellor of the California Community Colleges issue an Executive Order declaring Compton College to be an independent college under the authority of the Compton District effective June 7, 2019, at 11:59 p.m.

WHEREAS, on July 17, 2017, the California Community Colleges Board of Governors delegated to the Chancellor "the authority to make any required approvals and take any and all actions necessary or appropriate to ensure the continued accreditation of Compton College and to effectuate the transfer of the newly accredited Compton College from the El Camino District to the Compton District;"

THEREFORE, as the Chancellor of the California Community Colleges, I declare the following:

1. That the Compton College is an independent college under the authority of the Compton Community College District Board of Trustees, effective June 7, 2019, at 11:59 p.m.
