Student Driven Prescriptive Dual Enrollment Solutions

- 1. Provide a Faculty Dual Enrollment Coordinator.
- 2. Ensure transportation is secured in advance from High Schools to Compton College for the entirety of the district's academic year.
- 3. Align high school calendars with Compton College's calendar.
- 4. Explore the pros and cons of offering hyflex courses and define the college's process.
- 5. Continue the Academic Senate's recommendation to offer 2025 Fall Flex Day Trainings to assist faculty with teaching dual enrollment courses. Including dual enrollment pedagogical training and onboarding with High School staff to support student success (PCC Model).
- 6. Until calendars are aligned, Faculty provided calendars before the start of the semester to plan for high school calendar holidays and testing.
- 7. Relocate all dual enrollment courses to the Compton College campus where new, taxpayer-funded, state-of-the-art classrooms sit empty and unused, where faculty enjoy the support of colleagues and staff, and where students can have a legitimately college-level experience that will prepare them for university-level success.
- 8. Access to equivalent technology (Example—computers, projectors, & WIFI),

classroom and campus settings (air conditioning, accessible parking, & easy access to faculty restrooms) at high school sites—this includes a quality inspection to verify the week before courses begin. Until the changes and inspections occur, offer courses at Compton College to provide equivalent instruction and support to students.

9. No more than 50% of high school students should be embedded together in a single course with other college students. This is to preserve a college-level learning environment, with the robust discussions and diverse voices that such subjects require, including a mix of ages, backgrounds, and experience.

Course to consider: Ethnic Studies, Communication 120, English 103 etc...

- 10. Request the District provide peer reviewed articles and sources that demonstrate through data that dual-enrolled students do better in college courses when they are offered at high school campuses.
- 11. Request the District provide an explanation as to why half of on-ground English courses for Fall 2025 are being offered at high schools, compared to other courses. Additionally, provide percentages of courses and sections offered at high schools compared to the

- same courses offered at Compton College. This aims to clarify our high school and oncampus course offerings.
- 12. We are recommending the Academic Senate release time be provided for a new AS Dual Enrollment sub-committee co-chair position; an example of this model is our DEAC Faculty Chair.
- 13. Recommend that Admissions and Records clearly and effectively communicate to division chairs and faculty which online courses and on-campus courses will have high school students enrolled. Proactively, have this done before classes are selected for their schedules by the faculty.
- 14. Increase outreach efforts on adult learners. This includes a broader campus-wide conversation about acceptable longstanding ratios and diversifying adult learner outreach efforts.
- 15. Separate from the calendar, align the course days/times to match ours.

- 1. Have multiple breakout sessions with different topics.
- 2. Break outs for HS sites with HS staff to cover logistics like parking, restrooms, technology, entrance protocols, etc.

- 5. Workshop on Classroom management
- 6. How HS students can access Student Support Services
- 7. High school student workload. These students are routinely taking 9-10 courses (student reported).

COMPTON COLLEGE ACADEMIC SENATE RESOLUTION

Request for Formal Sanctuary Campus Designation for Compton College

- Whereas, the Academic Senate for California Community Colleges (ASCCC) has affirmed the role of community colleges as inclusive institutions that uphold the educational and human rights of all students, regardless of immigration status; and
- Whereas, Compton College is committed to cultivating an educational environment grounded in equity, diversity, inclusion, and access, and recognizes the specific vulnerabilities faced by undocumented students, Deferred Action for Childhood Arrivals (DACA) recipients, and students from mixed-status families; and
- Whereas, the uncertainty caused by shifts in federal immigration policy, as well as the potential presence of immigration enforcement agents on or near college campuses, has created real and perceived threats to the safety, well-being, and academic success of affected students; and
- Whereas, many institutions of higher education throughout California have adopted "Sanctuary Campus" policies that communicate clear commitments to limiting cooperation with immigration enforcement, protecting student data and privacy, and providing robust support for undocumented and vulnerable student populations;
- **Resolved**, that the Compton College Academic Senate formally supports the designation of Compton College as a Sanctuary Campus, as an institutional affirmation of its commitment to protecting the rights, dignity, and educational access of all students; and
- **Resolved**, that the Compton College Academic Senate respectfully and formally requests that the Compton Community College District and its Board of Trustees officially designate Compton College as a Sanctuary Campus through the adoption of a resolution, board policy, or administrative regulation that explicitly outlines the college's commitment to:
- Restricting access to campus property by immigration enforcement agents unless

required by law or court-issued warrant;

- Protecting student privacy and limiting the release of personally identifiable information without consent or due legal process;
- Prohibiting the use of district funds, personnel, or resources to assist or cooperate with immigration enforcement activities;
- Expanding access to legal, mental health, and academic support services for undocumented students and their families; and
- Providing training and resources to faculty, staff, and administrators on relevant rights, protocols, and student support services;
- Expanding investment towards the continued education and financial support of undocumented, AB540, DACA, TPS, International and all students impacted by attacks on the rights to education via anti-immigrant policy; including international members.
- Ensure students are notified of the presence of ICE on or near campus as soon as the district becomes aware of their presence.

Resolved, that the Academic Senate encourages the College President/CEO to work collaboratively with district leadership, student services, and legal counsel to develop the necessary frameworks and procedures to implement the Sanctuary Campus designation in practice; and

Resolved, that this resolution be forwarded to the Compton Community College District, the Board of Trustees, the College President/CEO, and the Academic Senate for California Community Colleges (ASCCC), and that the Compton College Academic Senate publicly reaffirm its commitment to standing with and supporting all students, regardless of immigration status.

AR 4010 Academic Calendar Issued: Month XX, 20254

References:

Education Code Sections 79020 and 88203; Title 5 Sections 55700 et seq. and 58142

"The President/Chief Executive Officer (CEO) shall establish a Calendar Committee, in consultation with Academic Senate, CCCFE faculty and classified units, and the ASB, that includes representation from appropriate constituent groups."

<u>The President/Chief Executive Officer (CEO) shall establish a Calendar Committee, in consultation with Academic Senate, CCCFE faculty and classified units, and the ASB, that includes representation from appropriate constituent groups.</u>

The Calendar Committee shall develop an academic calendar that will be subject to negotiations with the District as stated in Article 15.3 in the Faculty Federation CBA, and such negotiations shall take place no later than 30 calendar days before submission to the Board of Trustees.

As specified in Board Policy 4010 the academic calendar is subject to negotiations between the Compton Community College Federation of Employees (Certificated) unit and the District. The academic year consists of 175 days of instruction based on a standard 18-week calendar. Classes in the primary terms (fall and spring) are offered on a compressed academic calendar that is consistent with the Education Code's required 175 days of instruction.

<u>Full-time contract or regular faculty members shall serve a maximum of 175 instructional</u>

days, plus two non-instructional days for each academic year of this Agreement. The two

non-instructional days shall be orientation and commencement. The Academic Calendar shall include a new faculty Orientation day for both full-time and part-time faculty. There will also be one non-teaching day during which no instruction or District/faculty activities shall be scheduled.

If an unforeseen natural disaster or emergency occurs which results in school not being held, faculty members shall make up the lost number of instructional days to meet the 175-

<u>day calendar at no additional remuneration. If such missed days are forgiven by the County</u>

and/or state governments, faculty members are not required to provide any additional days

without remuneration.

As described in Administrative Regulation 2511 - Council and Committee Structure, the Calendar Committee shall develops and maintains at least a two-year academic calendar cycle for Compton College. The Calendar Committee will-recommends the academic calendar to Consultative Council, which willis then recommended to the President/Chief Executive Officer (CEO). Once the President/CEO Consultative Council acts and reports back to the co-chairs of the Calendar Committee, the academic calendar willis then be used to begin bargaining with the Compton Community College Federation of Employees (Certificated) unit. Board of Trustees. Once agreement has been reached through the bargaining process, the academic calendar <a href="will-be-

The District shall be closed on the following all holidays legally mandated and in accordance with the California Community Colleges Chancellor's Office (CCCCO):

- New Year's Day (January 1)
- Dr. Martin Luther King, Jr. Day (Third Monday in January)
- Lincoln Day (February 12 or see Note below)
- Washington Day (Third Monday in February)
- Memorial Day (Last Monday in May)
- Juneteenth (June 19)
- Independence Day (July 4)
- Labor Day (First Monday in September)
- Veterans Day (November 11 or see Note below)
- Thanksgiving Day (Fourth Thursday in November)
- Christmas Day (December 25)

When a holiday falls on a Sunday, the workday immediately following shall be deemed to

be a holiday in lieu of the day observed. When a holiday falls on a Saturday, the workday

immediately preceding shall be deemed to be the holiday in lieu of the day observed.

Employees follow the holidays negotiated in their respective collective bargaining agreements.

Federation of Employees Holidays

Holidays for members of the bargaining unit shall be as they appear in the Instructional Calendar.

Any day declared by the President of the United States as a public fast, thanksgiving, or

holiday, or any day declared a school holiday by the governor of the state or the Governing

Board of the District under state law, shall be a holiday for all members of the bargaining

unit. The college shall remain in session on all special or limited holidays appointed by the

President or the governor of the state.

Federation of Classified Employees Holidays

The following holidays will be observed by the classified employees: New Year's Day, Martin Luther King Day, Lincoln's Day, Washington's Day, Memorial Day, Independence Day, Labor Day, Admission Day, Veteran's Day, Thanksgiving Day, Cesar Chavez Day, and Winter Holiday.

Cinco de Mayo, the Friday during Spring Recess, the Friday succeeding Thanksgiving Day, the day preceding Winter Holiday, and New Years Eve Day. Cinco de Mayo and Cesar Chavez Day shall be taken by affected unit members during the scheduled winter break on days determined by District administration. Unit members shall be notified of these scheduled days by November 15th of each academic year.

Other Holidays:

The Board of Trustees may declare other days to be holidays and close the college and offices when good reason exists while maintaining the 175 days of instruction for the primary terms. These holidays include New Year's Eve day, the Friday of Spring Break, the day after Thanksgiving, and Christmas Eve day among others as determined through the consultative and bargaining processes.

Note: Per Education Code 79020, the District shall close on every day appointed by the United States President as holiday and not listed above. Some dates may differ as allowed by the CCCCO guidelines.
