#### 3. Reports:

- a) Vice President, Academic Affairs VP Berger
  - Thank you to committee and Sean for all hard work throughout the year. There has been a lot of curriculum changes, new programs, regular course reviews, and inactivations. We have been independent from El Camino College for 3 years. A lot of courses were brought from El Camino College without knowing what would happen as an independent college. Now that we see what we are are not offering and what we can't offer, it's a good time to reflect on what makes sense for Compton College (see what we actually offer and what works for us). Example, the Nursing courses that are getting inactivated. We created new curriculum for Nursing but still have the old NURS courses in the catalog. The catalog is supposed to reflect what we actually offer at college. If we have no intention (in the near future) to offer a class, then inactivation is the right thing to do. It helps us focus our resources on what we know we need to offer and help our students complete their programs. At the same time, we are also making new courses and programs that makes sense for our students. We often have courses that are required for a degree/program but it always gets cancelled due to low enrollment. In this case, we should figure out a way to restructure the program so that the course would not be required if it's no longer a skill that is needed in the industry. We also need to have

conversations on what is needed in the industry/work force and make changes to our programs as needed. We should look at it as a clean up and refocusing of our programs. Now is a good time as we are working on the ISER and trying to present ourselves in the best light possible.

#### 6. Information Items:

- a) One remaining Spring 2022 Curriculum Open Lab: 3:00 p.m. to 4:00 on May 9th.
  - Sean was approved for summer curriculum hours. Will hold Curriculum Open Labs and PD opportunity over summer
- b) One remaining College Curriculum Committee meeting: 5-24-22.
  - In the past, we needed to have a last special meeting to approve last minute items. There is a chance, we might need a meeting a few days before last Academic Senate meeting to approve curriculum changes
- c) CNET sandbox—program inactivation and fourth hybrid option.
  - There was a glitch in the material section where an author could not revise the rationale for an older textbook. It was an easy fix so didn't build an entire sandbox for this.
  - Wants to create sandbox to hold 4<sup>th</sup> option for distance education (hybrid option). For example, a CTE course (WELD, ATEC, COSM, etc.) would have the opportunity to offer lecture in hybrid format during regular time and hold lab in person. Maya will try to add it to sandbox soon to get it approved by Curriculum and Senate.
    - Todd K.: What would be the process to get it approved through curriculum?
      - If courses have DE addendum in CNET already, then faculty would just click the fourth option for "hybrid" and let it run through the approval process.
  - A second template that we're working on will address program inactivations. Current process for program inactivation is not as simple as it could be.
- d) In the past 3 years, we've been focusing on resolving curriculum issues. Moving forward we might be able to focus on more fun things like taking on a holistic approach to make recommendations and changes. Things like the DEI component, making minor revisions in CNET, looking at new programs, and looking at what can complement our current courses/programs.

#### 7. Discussion Items:

  - Sean M.: Dr. Flor, can we do an electronic vote to inactivate the old Business Program?
    - Dr. Paul: Yes, it is also on the agenda for the next division meeting
    - VP Berger: To provide more context, ADT templates are reviewed every 5-6 years. During last review, Business program had large changes made that went into effect for new students starting Fall 2022. Last program that was approved in Senate is old. We want to avoid having 2 ADT Business programs in the next catalog to avoid confusing students. Students that started in the original program can complete it as long as they keep catalog rights. Inactivation of the old Business program will only occur until it is inactivated at the state level.
