 - Reviewed Articulation News (document with updates below)
 - There was a discussion regarding offering online labs, some questions include:
 - Should the science and foreign language online labs not be approved for DE?
 - We can keep the courses as is until next approval cycle. Need to focus on educating each other that online labs may not be accepted for major preparation courses
 - Where can we notate that the online labs do not transfer for their major prep? If not approved by institution, student will need to retake course at institution
 - Should we add information in catalog?
 - It would be non-issue if we don't offer the course lab portion online.
 - Is there an update on American Institution requirement? There were previous discussions to make it an upper division requirement

- No changes; will stay the same. The American Institution requirement is a CSU graduation requirement that doesn't stipulate it has to be lower division vs upper division. We encourage students to take it with us due to lower cost of the class

 - AR4105 is still under review. Will be an agenda item for approval in next DEAC meeting. Once approved, it will be sent to Academic Senate for approval

- Michael VanOverbeck motioned to approve Action Item 5a. Nathan Lopez seconded. Approved
- a) Revised CCC Handbook to add proxy voting to make quorum.
 - Brown Act stipulates that you can have proxy voting as long as it is in the bylaws
 - Maya M.: How many committee members can carry a proxy per meeting?
 - Sean M.: Might only request proxies to make quorum, based on how many voting members are present
 - We need to clarify that it is one-to-one for proxy as well as specify the max proxies allowed per meeting.
 - o Correction: "at-large"
 - Add: "One Proxy per voting member..."
 - Add a limit on how many total proxies allowed per meeting: "no more than two proxies per meeting..."
 - Proxies should not outnumber the standing representatives.
 - Should it be a number or percentage of voting representatives?
 - Group agreed that there should be no more than 2 proxies max per meeting
 - Sean will add CCC Handbook with revisions to Academic Senate agenda for approval

Course Reminders

Online Labs

As of today, universities are back to normal, pre-pandemic operations regarding online labs:

- Online labs are acceptable for general transfer/articulation (meet UC/CSU credit towards the 60 units).
- Online labs *may not* be accepted for meeting Major requirements (this includes Nursing and similar programs).
- Some institution's policies:
 - UC Santa Cruz: Acceptance of online labs through summer 2023.
 - University of Southern California: Science labs must be in person; Foreign Language requirement courses must be in-person.
- Unlike pre-pandemic era, universities are checking class schedules since transcripts do not denote the mode of delivery for courses

Bottomline: Acceptance of lab (or hybrid) courses must be verified with the institution's department.

Transfer Implications: Science Course Sequencing

- Universities prefer that students complete their science course sequence at the same institution.
- Students who do not complete the sequence at the same institution may need to submit a petition for those courses to be applied towards their major requirements.

Policies & Mandates

Ethnic Studies Graduation Requirement

- CCCCO
 - Deadline: Fall 2024
 - o CCC Associate Degree Ethnic Studies Requirements FAQ
 - Competencies referred to the Intersegmental Curriculum Workgroup's (ICW) Model Curriculum Workgroup (MCW) for final review.
- University of California:
 - All students beginning at Compton College (or any CCC) **Fall 2023** or later are required to have completed *IGETC Area 7 Ethnic Studies* (Area 7 mimics the CSU Area F requirements). It is very important that students are IGETC or CSU GE Certified.

AB 928 Student Transfer Achievement Reform Act of 2021

- Next Meeting: <u>April 25</u>
- The law requires:
 - o Establishes the Associate Degree for Transfer Intersegmental Implementation Committee
 - Requires CCCs to automatically place students who declare transfer on their major Student Educational Plan (SEP) ADT pathways (where applicable/if exists; students can opt out)
 - Requires <u>Intersegmental Committee of the Academic Senates (ICAS)</u> to establish a singular lower division general education pathway. Singular GE Pattern must be finalized by May 31, 2023 or administrators from each segment determines
- California General Education Transfer Curriculum (CalGETC)
 - <u>Intersegmental Committee of the Academic Senates (ICAS)</u> to establish a singular lower division general education pathway. Singular GE Pattern must be finalized by May 31, 2023.
 - o <u>ASCCC: Statement on Cal-GETC Approval (Feb. 9, 2023)</u>
 - <u>UC Assembly Approval of Senate Regulation 479 (Cal-GETC)</u>
 - CSU Area E being an upper division course was never under discussion by the CSUCO
 - Awaiting General Education Criteria from ICAS
- ADT Auto-enroll
 - o By August 1, 2024
 - Where ADTs for major pathways exist...shall place students on the ADT pathway if students declare a goal of transfer on their mandatory ed plans
 - Opt-outs: Students who are UC or Independent bound, or no ADT path exists for major, or a CTE student, or a Bachelor Degree Program student
 - Guidance in this area is still pending.
- AB 928 Committee (excerpted from Spring 2023 CCCCO SCIAC Update)
 - Purpose
 - Primary entity charged with the oversight of the Associate Degree for Transfer (ADT)
 - Ensure a reduction in the number of excess units accumulated by CCC students before transfer

- Eliminate repetition of courses at four-year postsecondary colleges and universities taken by CCC students who successfully transfer
- Increase the number of CCC students who transfer
- Enhance coordination and communication between four-year postsecondary colleges and universities and the CCCs
- Outcomes
 - Provide the Legislature and the Governor with recommendations
 - Before December 31, 2024
 - Establish TMC timelines and reporting deadlines for regular review
 - Create additional TMCs/ADTs related to workforce demands
 - Develop a comprehensive communications plan about the ADT pathway
 - Review & identify updates needed to the ADT website
 - Before December 31, 2023
 - Selected issues impeding the scaling of the ADT and streamlining transfer
- o Study Groups
 - GOALS: "Identifying annual goals for increasing transfer rates in California and closing racial equity gaps in transfer outcomes to be adopted by the state."
 - STEM: "Proposing a new unit threshold for STEM degree pathways that meet the requirements for admission to the California State University and the University of California."
 - **REENGAGEMENT**: "Reengaging **ADT earners who do not transfer** or apply for transfer into a four-year postsecondary educational institution."
- Next Steps
 - Developing legislative recommendations
 - Investigating key transfer barriers and articulation complexities
 - Planning for Auto ADT (CCC lead)
 - Planning for a communications plan & guidance for ADT/transfer
 - Planning for review and updates needed to the ADT website (CCC managed)
 - Planning for TMC review timelines and reporting deadlines
 - Planning for TMC development for workforce needs
 - Planning for a final report

AB 1111 Common Course Numbering

- Deadline: July 1, 2024
- <u>Common Course Numbering Landscape Scan</u>
- **Preliminary Commonality Attributes:** Course number & Course title; Unit amount; Modality; Pre/Corequisites; SLOs (ACCJC); Course Objectives; *General Education area (s); Major/department articulation*
- Meetings & Timeline
 - February 23 Meeting:
 - A main concern is that important elements of the Course Outline of Record (COR) [Objectives, Content, Prerequisites, Units/Hours] will not be common. These affect articulation – if the CSU/UC will not accept can be problematic. Example: UCLA Philosophy Major: Philosophy 020 @ LA Mission College is articulated, but not at LA Harbor College.
 - Course Titles, Prefix and Numbering are typically 'common'. These elements are not considered for articulation with the universities

- Articulation is not a purview of this bill and the Taskforce, but how can the CCCCO commonly apply pressure to the CUS/UC. CCCCO needs to be aligned.
- Streamlining how we identify CSU Transferable courses.

New Legislations Being Proposed:

- **AB 811 (Fong) Repeatability:** From 3 to 5 for either substandard result, or for enrichment/skill building (new); Priority reg. for students who require course for major, and to students who have not taken the course
- **AB 506 (Fong), AB 654 (Cervantes)** Ethnic Studies Articulation: mandates the CSU & UC to collaborate with the CCCCO for Ethnic Studies course articulation.
