- a) <u>Second Read—New Courses</u>: ESTU 101H Honors Introduction to Ethnic Studies; ESTU 150 African American Psychology; FILM 130 LGBTQ+ Film; PE 110A Body Conditioning and Physical Fitness (Beginners); PE 110B Body Conditioning and Physical Fitness (Intermediate); PE 110C Body Conditioning and Physical Fitness (Advanced); PE 125A Weight Training (Beginners); PE 125B Weight Training (Intermediate); PE 125C Weight Training (Advanced); SOCI 207 Introduction to Human Services and Social Work; SOCI 208A Social Work and Human Services Seminar; and SOCI 208B Fieldwork in Social Work and Human Services.

Action Item 3a Approved

- b) Second Read: CurriQunet Course Outline of Record DEI Template Draft.
 - Consensus to call it DEIA
 - Consider making DEIA template optional for faculty for the first iterations until it is mandatory by Chancellor's office. Similar thing happened with DE addendums, it was optional but most faculty completed it
 - o Potentially provide a notation or asterisk on catalog to notate that the course is DEIA
 - Maya M: DE addendum is optional in CurriQunet? The course has to be approved before it can be taught online
 - Sean: Correct, but it is still optional for faculty to submit and teach the course online
 - o On DEIA template, changed answer options to 'yes' or 'not applicable' and requires explanation for all responses
 - o Ouestion 6
 - Nathan: Some textbooks can be handbooks. If they put 'not applicable' for this answer (like CTE courses), does this mean it does not meet the DEIA? Would everyone have to hit yes on every answer to meet DEIA? How would someone meet DEIA?
 - We can discuss at end of template
 - Hassan: There might be some subjects that do not have diversity. What would they answer?

- Can click 'not applicable'. This would provide faculty an opportunity to explain why it does not apply
- Hassan: Recommendation to Change "Conflicting" to "diverse" or "different" views
 - Melain: question can end after "philosophies"
- o Question 7:
 - The committee discussed changing some of the language to be more appropriate and encompass diversity - Including all areas of identities vs keeping it broad to not leave out any identity. Committee decided to end the question after "diversity of identities"
- o Question 8:
 - Change: Start with "this course..." and remove "?" at end of statement
 - The committee discussed why COR/ZTC options can't be required. COR can't mandate what each faculty does and infringe on academic freedom. Since COR is general, COR/ZTC options can be part of the list of recommendations but it can't be mandated
- Ouestion 10:
 - Discussion centered around assessment and if it was necessary to include this question since it was similar to another question and assessment is already included in COR. Removed reference to multiple learning styles and ended after UDL. Statement now reads: "the course activities are aligned with the principles of a Universal Design for Learning (UDL)" with UDL being linked for faculty that do not know what it is
- o Question 12:
 - Discussed the need to make it simpler
 - Change "support" to "use" and change "to" to "with"
- Hassan Elfarissi motioned to approve DEIA template and send it to COR Committee.
 Shay Brown seconded. Approved
