- **Athletics:** Mercedes Luna, Director of Student Development and Athletics  
Dr. Luna emailed the committee and provided the following update.

I cannot attend the meeting due to a conflict in my schedule. The issue I presented last meeting about the potholes in the alleyway between the V and W buildings has worsened due to the ongoing rain. I feel it is a major hazard as this alleyway experiences a lot of foot traffic, particularly from athletics staff, student-athletes, St. John’s employees, and others on campus.

In addition, there are several leaks in our weight room and gym. These have been previously reported to M&O (including photos), and athletics was advised that as long as the water was not impacting the equipment, we were fine. However, the water is pooling in walkways creating a great safety issue. I am also concerned about structural damage and issues with mold that this may create.
