Subject: President/CEO Message - August 15, 2025

# Campus Community,

Yesterday, I had the opportunity to present at the California Student Aid Commission (CSAC) event in Chula Vista, CA, on the topic: "Defining Student Success for All Students with a Focus on Equity." I shared insights on statewide and federal initiatives impacting California Community Colleges, including legislation that strengthens financial assistance for our students, including adult learners and undocumented students. I also highlighted <a href="Compton College's 2035 Comprehensive Master Plan">Compton College's 2035 Comprehensive Master Plan</a>, which centers on a singular goal: to accelerate student completion while advancing equity and success.

As part of the presentation, I discussed expanding the Completion by Design Framework to include Return on Investment (ROI) for students. I explored both perceived and real barriers—as well as opportunities—for students to maximize their ROI after earning a degree or certificate, not just at Compton College, but across all California Community Colleges. Finally, I encouraged them to support the following policy reform changes:

- **AB 540 (criteria):** "Dual Enrollment for Adults" Allow students with two years of formal education and/or participation in structured dual enrollment (noncredit/credit or high school/college) to qualify. *Why is this important?* Currently, residency benefits exclude many adult learners due to the 3-year eligibility criteria and enrollment timing.
- Cal Grant C (eligibility): Automate eligibility via college-provided cohort files, eliminate scoring rubric.
  - Revise the ranking system to prioritize high-demand Career and Technical Education fields common among adult learners.
  - Link Ability-to-Benefit to Cal Grant C.
- Why is this important: Noncredit programs/courses are ineligible for funding.
- **Dream Service Incentive Grant (DSIG):** Expand DSIG access among AB 540 students in high-demand fields. *Why is this important:* Funding is tied to Cal Grant C eligibility and limited to nonprofit partners.

We will be working with legislators and the California Student Aid Commission to initiate policy reform conversations, as they are critical to our goal of expanding programs and services for adult learners, particularly those at adult schools within our district. ### Fall 2025 Enrollment Update

As of *August 14, 2025*, Compton College has generated 1,391 Full-Time Equivalent Students (FTES) for the Fall 2025 term. 9,618 (55%) of the available Fall seats are currently filled.

Fall enrollment trends are holding steady, but have not continued to close the gap compared to last year's figures. As of now, our FTES stands at 1,391, which is 6.0% lower than this time last year. Headcount is currently 4,028, trailing last year by 2.9%. Enrollment remains a top concern, as always. We're hopeful that this week will bring a surge in registrations, especially as we work to finalize the processing of dual enrollment students for Fall 2025.

Please continue to encourage students to <u>check the class schedules on the Compton College website</u>, meet with an advisor, and register early to ensure a smooth start to the semester. *Every Full-Time Equivalent Student Counts!*

On a personal note, Compton College will always hold a special place in my heart and my family's story. I was raised here and have spent most of my professional career here. My son graduated from our Child Development Center, and I still remember that day, as he said he wanted to be a college president.

I want to share a personal story that captures the spirit of our college. I've had the pleasure of watching the educational journey of Diamond Hatten, daughter of Felecia Hatten, our Interim Associate Registrar. I remember Diamond visiting my office often when I was Dean of Student Services—usually during late hours—and she continued to drop by even after I became CEO. Her visits were always unannounced, but always welcome. Diamond graduated from Compton College and often brought prospective students with her to enroll. This year, she graduated from Prairie View A&M University with two degrees: a Bachelor's in Social Work and a Bachelor of Science in Psychology. Since I wasn't available to attend her graduation day, she sent me a video of her walking across the stage. I'm incredibly proud of her and her accomplishments. More than that, Diamond reminds me of the lasting impact our college has on students, employees, and the community.
