Subject: President/CEO Message - September 19, 2025

Campus Community,

The Fall 2025 semester is moving quickly, and I'm pleased to report that enrollment continues to improve. As we support our students in achieving their academic and career goals, it's important to emphasize the value of declaring a major early and using financial aid wisely.

In previous messages (March 28, May 2, July 10, July 31, August 7, and August 29), I've shared our ongoing focus on Compton College 2035, particularly around Return on Investment (ROI) and Economic Mobility. These priorities are also reflected in federal legislation, including the *One Big Beautiful Bill Act (H.R.1)*.

To improve ROI and Economic Mobility, students must commit to a clear program of study and follow a guided pathway. This approach helps them complete credentials on time, reduce unnecessary costs, and maximize the impact of financial aid. It also positions them for higher earnings after graduation.

In *August 2025*, I received unit count data for Compton College students who received federal financial aid over the past three academic years:

We have too many students accumulating more than 90 units, which can severely impact their federal financial aid eligibility if they transfer to another institution. According to our Compton College 2035 Institutional SetGoal, the target average for degree completion is 67 units. In 2023–2024, the average was 79 units. Please note, under 34 CFR § 668.34(a)(5), students must complete their program within 150% of the published length of the program. For example, for associate degree or transfer programs, federal financial aid is available for up to 90 units. For certificate programs requiring 30 units, federal financial aid may cover up to 45 units.

Additionally, from 2019 through 2025 (excluding the current academic year), we have disbursed \$3,645,579 in student loans. Many of our students rely on federal financial aid and loan programs, so it's critical that we guide them toward timely completion and informed decision-making.

We must stay focused on aligning academic programs with labor market needs, promoting financial literacy, and helping students make choices that lead to meaningful careers.

Today's President/CEO Message features several key updates worth celebrating: the Fall 2025 Community Newsletter has been published as part of our career education campaign; fall enrollment is up, thanks to the collective efforts in recruitment and retention; and the date for our annual Tenure Dinner has been set for *October 9*, 2025. Additional updates and announcements are also included.

Enrollment Update – Fall 2025

As of *September 18, 2025*, Compton College has generated 1,751 FTES for the Fall 2025 term. 12,440 (72%) of the available seats are currently filled.

Fall 2025 enrollment is strong due to our collective efforts, with unique headcount more than 13% ahead of last year at this time. FTES is up nearly 5%, and seat enrollment has increased by almost 9%. There's still time for students to add a "Midterm/ Late Start" class. Please encourage those interested to explore the wide variety of 8-week, full-credit courses beginning in October.

Community Newsletter Now Available

We're excited to share that the Fall 2025 Community News is now live! This edition of the annual newsletter is part of an ongoing career education campaign, which began last spring and continues through October. - DROP to the ground
- Take COVER by getting under a sturdy desk or table
- HOLD ON until the shaking stops

Those who are inside should remain indoors, while those who are outside should remain outdoors.

President/CEO Closing the Loop

As a follow-up to the <u>President/CEO Message - August 29, 2025</u>, I want to share that through CDWL on *September 5, 2025*, Compton CCD has officially submitted our appeal to the IRS regarding our Employee Retention Tax Credit (ERTC) application that was reversed. We will continue to provide updates on the status of the ERTC funds and the ERTC reversal funds in future President/CEO Messages.

Final Thoughts

As we continue to monitor decisions from the U.S. Department of Education, I want to highlight the Compton College Upward Bound Math and Science (UBMS) program. Funded through a five-year grant from the Department of Education, UBMS will conclude in August 2027. The program offers academic support and enrichment to 9th–12th grade students who are first-generation, low-income, and/or have a disability, with a

focus on preparing them for careers in STEM fields. UBMS is funded at \$309,505 for both the current and upcoming year.

As we approach the end of this grant cycle, it is essential to begin planning and developing a strong proposal to ensure continued funding and support for our students beyond 2027.

UBMS proudly serves students from Compton High School, Dominguez High School, and Centennial High School. Over the past three years, we have supported 163 students, empowering them to strengthen their academic skills, explore STEM pathways, and prepare for college success. We look forward to building on this impact and continuing the program's growth in the next funding cycle.

This week, we also received exciting news: Compton College has been awarded a National Science Foundation (NSF) grant totaling \$930,833 for the project titled *Breaking Down Barriers to Biotech Careers*. Congratulations to Dr. Katherine Marsh, who initiated the proposal on behalf of Compton CCD, and thank you to everyone who contributed to this successful effort.

Additionally, on *Monday, September 15*, 2025, we were invited to submit a proposal to the Eli and Edythe Broad Foundation to support the Compton Community Health Professions Partnership. This initiative includes Compton College, Compton Unified School District, California State University, Dominguez Hills, and Charles Drew University. The proposal is due *today, September 19*, 2025. Special thanks to Dr. Adrian Trinidad, Interim Director of Adult Education and Workforce Development, for leading the submission on behalf of the partners. Compton CCD will serve as the fiscal agent for this grant. We are hopeful that we will receive these funds to support our students and community further.
