WHEREAS, Oliver W. Conner served his country in the Army for two years and was discharged with the rank of Sergeant, stationed in Germany and Ethiopia. He traveled extensively before returning home and developed a love for travel which lead to a 40-year career with Western/Delta Airlines, and;

WHEREAS, Oliver W. Conner founded his real estate business, Pyramid Properties in Lynwood and was active in that business until his death. While working as a real estate broker he also gradually built up a thriving business, owning over tweny properties at the time of his death and;

WHEREAS, Oliver W. Conner was a faithful and active member of the Lynwood Rotary Club, serving as President of the Lynwood Rotary Club, and;

WHEREAS, Oliver W. Conner was characterized by his closest friend as generous of spirit, responsible, helpful, resourceful, disciplined and able to sustain an amazingly stable positive attitude and tireless optimism in spite of serious health challenges throughout much of his adult life, and;

WHEREAS, Oliver W. Conner in recognition of the role that Compton College plays in the education of the community and the opportunity the College provides to first generation college students, made a generous bequest to the college to support that mission, and;
