open for summer. The decision has been made to open up to 30% of our classes on campus and 70% online. We are trying to manage what areas people are in and also cleaning up those areas.

The Compton Community College District Financial Audit for the last fiscal year has been completed, and the District is in the process of preparing the budget. The tentative budget for 2021-2022 will be submitted to the Compton CCD Board for approval at the June 15, 2021 Board of Trustees meeting.

The Compton CCD is planning on hiring a Director of Black and Males of Color Success that will be integrated into the Guided Pathways work.
