2010 District Populations

The Compton Community College District last redistricted in 2012 with a Board of Trustees and a Redistricting Committee process based on the 2010 Decennial Census.¹

As the following table shows, utilizing the American Community Survey (ACS) data from the 2006-2010 vintage which would be used in their 2012 redistricting, all five districts had 50% or more of a single Citizen Voting Age Population (CVAP) ethnic/racial subset. Districts 2 and 5 both had a Black CVAP of almost 60%, and districts 1, 3, and 4 had Latino CVAPs of over 51%.

Population Growth and Deviations

The Statewide Database has released reallocated state prison population, the final dataset that cities and counties must use to comply with the Fair Maps Act. This population identifies the whole count of persons and where they resided as of April 1, 2020 with the state prisoner reallocation per state law. Redistricting Partners has concluded the work of placing this data into the census blocks, block groups, and tracts.

Based on this data, Compton CCD's total population has stayed relatively similar since the last redistricting, growing at a rate of 1.1%. All five districts saw mild changes in their population growth and losses. District 2 saw the most gain in population with an additional 2,757 counted residents, a growth rate 4.8%, while District 3 had the highest decline in population, losing 1,122 counted residents—a negative growth rate of 1.9%.

¹ These counts are based on the 2010 data put into the 2020 Census geography. There may be slight differences as many census blocks were consolidated and this would cause counts to shift since the 2011 redistricting.

With a districtwide population of 307,229, the ideal population for any individual district be 61,446. The seat with the largest population is District 5 at 64,977 (+5.7%) and the smallest is District 3 at 59,157 (-3.7%), placing the district with a total deviation of 9.4%, below the 10% deviation range maximum.

Data on the ethnic and racial subgroups utilized for Voting Rights Act calculations have been finalized for the current redistricting cycle. This shows the composition of districts based on the racial makeup of eligible voters – those who are citizens and over the age of 18. The CVAP growth rate was 18.1%, much higher than the district's 0.4% growth rate.


Overall, the Citizen Voting Age Population growth was significant among Latinos and steady among Asians, while there was a negative growth rate among African Americans within district. Some of the most notable racial and ethnic changes include:

- The Latino CVAP grew by double-digits in all five districts
- Districts 1, 2, 3, 4 all have a Latino CVAP of over 54%
- District 5 went from a Black CVAP of 59.4% in 2010 to 49.1%
